
# **DISTRICT DEPUTY SUPREME KNIGHT** - William Horton, Jr.

### Supreme Court Takes the Cake

The U.S. Supreme Court affirmed the principle of religious freedom in its recent *Masterpiece Cakeshop* decision - but its narrow ruling in the case left unanswered the question of whether wedding vendors and other businesses can legally decline services for homosexuals and same-sex couples.

The high court's 7-2 ruling June 4 in favor of Jack Phillips, the owner of Masterpiece Cakeshop in Lakewood, CO, did not address the First Amendment free-speech issues that Phillips' lawyers from Alliance Defending Freedom and others litigated while the case was pending. That question was left for the court to decide on another day. Legal analysts say that the Masterpiece decision may not have addressed the free-speech claims directly, but it puts states and federal regulators on notice that they cannot discriminate against a business owner's religious beliefs. "The court strongly reaffirmed the free exercise of religion as a fundamental right, constitutionally enshrined, and I think that's really important, especially with this cultural shift away from appreciation for and approval of one of the core founding values of our country," said Joan Mannix, special counsel with the Thomas More Society.

Anti-Religious Bias - The dispute arose in 2012 when Phillips offered to sell the same-sex couple a premade cake or any other baked good in his shop, but not a personally created wedding cake. Instead, the couple stormed out of the shop and later filed a sexual -orientation-discrimination complaint with the Colorado Civil Rights Commission, even though same-sex "marriage" was not legal in Colorado at the time. One Colorado commissioner who voted to order Philips to design custom wedding cakes for same-sex couples claimed that freedom of religion had been used to "justify all kinds of discrimination throughout history, whether it be slavery, whether it be the Holocaust." "The neutral and respectful consideration to which Philips was entitled was compromised here," said Justice Kennedy, a swing vote in many of the high court's close decisions. Earlier, he included a plea for tolerance and respect for religious beliefs that echoed the 2015 majority opinion he wrote in Obergefell v. Hodges, which recognized a constitutional right to same-sex "marriage." "Finally, it must be emphasized that religions, and those who adhere to religious doctrines, may continue to advocate with utmost, sincere conviction that, by divine precepts, same-sex marriage should not be condoned," Kennedy asserted in the landmark 2015 decision. "The First Amendment ensures that religious organizations and persons are given proper protection as they seek to teach the principles that are so fulfilling and so central to their lives and faiths and to their own deep aspirations to continue the family structure they have long revered."

More Guidance Needed - But in the consensus view of legal analysts, the Supreme Court's Masterpiece decision failed to clarify how broadly First Amendment protections apply in cases involving the provision of services for same-sex wedding ceremonies. "The court's preference, I suspect, would be that people find ways to compromise and that people wouldn't file lawsuits over this issue," said Richard Garnett, a law professor and director of the Notre Dame Program on Church, State & Society at the University of Notre Dame. In Masterpiece Cakeshop v. Colorado Civil Rights Commission, the Supreme Court essentially "kicked the can down the road," said Gerard Bradley, a professor who teaches constitutional law at the University of Notre Dame. Bradley said that "The Supreme Court agreed to decide this case of its choice, but it turns out that they did not really know what to do - at least not yet - about redeeming the promise it made three years ago in the Obergefell same-sex 'marriage' decision, to make effective room for the decent and honorable beliefs of those who hold that marriage is between man and woman

**'Broader Implications'** - While the court's decision in Masterpiece is narrow in terms of its impact on freespeech claims, the ruling has "broader implications," said Douglas Laycock, a professor at the University of Virginia School of Law who studies and writes on religious liberty cases. Laycock said that plaintiffs in future cases "will have to do their homework and prepare their cases well" and be ready to disprove the "phony rationalizations" offered by regulators who decide cases where business owners with biblical beliefs are challenged under state publicaccommodation laws. Laycock, who filed an amicus brief in Phillips' favor, also said the court's Masterpiece decision is "huge" because if it had not sided with Philips, then the court would have undercut other religious liberty claims made under state constitutions and state Religious Freedom Restoration Acts, as well as other legislative efforts to grant exemptions for religious objectors. In cases without "smoking gun" expressions of hostility toward religion, as in the Masterpiece case, Laycock said religious objectors will need evidence of inconsistent treatment of other cases.

And in *Masterpiece*, the high court was also presented with evidence that the Colorado Civil Rights Commission had acted inconsistently in cases involving opponents of same-sex "marriage." Kennedy wrote that the commission concluded "on at least three occasions that a baker acted lawfully in declining to create cakes with decorations that demeaned gay persons or gay marriages."

# **ADVOCATES MESSAGE** - Joseph Virgilio

### **Charity Eligibility Tax Status**

The Knights of Columbus, from its founding in 1882, charity has been its first principle as envisioned by Father Michael J. McGivney mutual benefit society vision. The Knights of Columbus Supreme Headquarters in New Haven CT is recognized by the Internal Revenue Service (IRS) as a tax exempt organization under the tax charity code Section 501(c) (3).

In line with Supremes' tax exemption, the IRS additionally recognizes all "Councils" in the United States as "Fraternal Lodges" and Subordinate Units of "Supreme" and are also subject to tax code Section 501(c).

It should be noted that Section 501(c) of the IRC Tax Code establishes 28 different charity classifications of entities that may be exempted from federal income tax under charity status. The different categorizations of these entities are spelled out in the 501 (c) section and detailed requirements for them to take advantage of charity tax treatment

Local Councils of the Knights of Columbus fall under Section 501(c) (8) as "Fraternal Lodge" exempt entities, and may not, under any circumstances, establish themselves as 501(c) (3) tax exempt charitable corporation or charitable foundation.

Section 97 of Supremes' Laws of the Order, states that "Subordinate Councils" are unincorporated associations, which exist under their charters issued by The Knights of Columbus Supreme Council.

501(c) (8) entities are "fraternal beneficiary lodges, societies, orders, or associations operating under the lodge system and providing for the availability life, disability, or other benefits to the

members. (i.e. through an insurance program)

A fraternal benefit organization under this tax code is a group whose members are united through a shared charter and engage in common activities and consist of unifying characteristics or experiences. Activities may include ceremonies, rituals and significant community functions. This lodge system structure is composed of a parent organization (Supreme) and subordinate organizations, or lodges (Councils or Assemblies). To qualify for this 501(c) (8) exception under "Supreme" each Council must do the following:

- I- Obtain its own Employer Identification Number (EIN) from the IRS and submit its own tax return to the IRS (Form 990) each year; and
- 2- Provide its EIN and written authorization to the Office of the Supreme Advocate in order for it to be recognized under the Order's group exemption and local council charter status.

A Columbium Club, is classified a Section 501(c) (7) charity; and is a separate and distinct entity from the Knights of Columbus. Known as a tax exempt social Club. Columbian Cubs can own land, buildings, and bank accounts. Income comes from membership dues, rent and rentals and is subject to federal taxation. In order for a 501(c) (7) tax-exempt club to abide by IRS requirements, a substantial amount of the club's activities must further the club's exempt purposes (i.e. Charity). Generally, no more than 35 percent of the club's revenues can come from non-member sources. Additionally, a 501(c) (7) club could be subject to tax penalty or lose its tax exempt status if it engages in business outside of its exempt purpose or if it receives too much income from non-members.

Jonathan Scruggs, a senior counsel at Alliance Defending Freedom, the Christian public interest legal organization that represented Phillips pointed out that: "The actions the commission did are actually fairly common, in that you often have situations where there is unequal enforcement, and laws are applied with favoritism. He added that the *Masterpiece* ruling establishes "a firm rule" that government agencies cannot legitimately demonstrate hostility toward religious objectors. "They can't be equating people of faith with racists, discriminators or slave owners; that type of bias is improper...It's a significant win for people of faith everywhere; the government can't single them out and target their beliefs, especially in the con-

text of marriage. People of faith who have biblical beliefs about marriage can't be dismissed and excluded from the marketplace simply because of those beliefs." Important Distinction - Emilie Kao, the director of the Heritage Foundation's DeVos Center for Religion and Civil Society noted that the distinction between unjust discrimination and religiously informed views on marriage that the high court recognized will be "very important moving forward...we think the hostility shown by the state of Colorado toward a person like Jack Phillips because of his views on marriage shows the need for legislation, both in Congress and at the state level, to protect people who have the same beliefs about marriage as Jack Phillips,"

# ? DID YOU KNOW THIS ? - Joseph Virgilio

### Famous Knights of Columbus

James T. Mullen - From 1882 to 1886 he held the title of 1st Grand Knight of the Knights of Columbus. Ist Knight of Columbus who influenced Father Michael J. McGivney to change the name of the organization from Sons of Columbus to the Knights of Columbus right at the inception of the organization. Designed the emblem of the order, During the Civil War, he served in Company C of the 9th Regiment as Sergeant of the Company. To a large segment of American Catholics, Columbus was a hero, and James T. Mullen's suggestion of naming him as a patron was to some extent an effort to bridge the gap between the Irish Catholic founders of the Order and Catholic immigrants of other nationalities residing in Connecticut

John Fitzgerald 'Jack' Kennedy - A member of the Bunker Hill Council from Charlestown, Massachusetts, was the 35th President of the United States from January 20, 1961 to November 22, 1963. Assassinated in Dallas, Texas on November 22, 1963.

<u>Carl A. Anderson</u> - Former Special Assistant to the President <u>Ronald Reagan</u> (1983–1987).

Current Supreme Knight of the Knights of Columbus. Venerable Fulton John Sheen - American bishop of the Roman Catholic Church known for his preaching and especially his work on television and radio. His cause for canonization as a saint was officially opened in 2002. In June 2012, Pope Benedict XVI officially recognized a decree from the Congregation for the Causes of Saints stating that he lived a life of "heroic virtues"

### Government

John Ellis "Jeb" Bush - American politician. He served as the 43rd Governor of Florida from 1999 to 2007. He is the second son of former President George H. W. Bush and the younger brother of former President George W. Bush.

<u>Martin Patrick Durkin</u> - U.S. <u>Secretary of Labor</u>. <u>Raymond Flynn</u> - Former U.S. <u>ambassador</u> to the <u>Holy See</u> and former Democratic <u>Mayor</u> of <u>Boston</u>.

<u>Sargent Shriver</u> - U.S. <u>ambassador</u> to France and first director of the <u>Peace Corps</u>.

**John Volpe** - U.S. Secretary of Transportation and former Governor of Massachusetts (1961–1963 and 1965–1969).

### Media

<u>Steve Doocy</u> - Journalist and anchor for Fox and Friends.

**loyce Kilmer** - Famous journalist and poet.

<u>Jerry Orbach</u> - Jerome Bernard "Jerry" Orbach was an American actor and singer.

### **Sports**

George Herman "Babe" Ruth, Jr. - American baseball outfielder and pitcher for the NY Yankees, who played 22 seasons in Major League Baseball from 1914 to 1935. He was one of the first five inductees into the National Baseball Hall of Fame in 1936.
